



Florida Renewable Energy Technologies Sales Tax Program Application

INSTRUCTIONS

Florida Renewable Energy Technologies Sales Tax Exemptions will be issued in accordance with F.S. 212.08(7)(ccc), date of application and upon availability of funding. The exemption is available to a purchaser only through a refund of previously paid taxes.

COVER SHEET

- *General Information:* Provide the requested information for the purchaser along with background information on the renewable energy project.
- *Summary of Sales Tax Paid:* Provide a total for each category which applicant is seeking Florida sales tax exemption.
- *Applicant Certification:* Applicant must sign to certify compliance with F.S. 212.08(7)(ccc). The project manager must sign to certify as well.

DETAIL SHEETS

For each category applying for:

- Complete the accompanying Detail Sheet.
- Provide an itemized list and description of all equipment, machinery and other materials for which applicant is seeking Florida sales tax exemption. When applicable, include serial number or other permanent identification number.
- Attach sales invoice(s) or other proof(s) of purchase showing the amount of sales tax paid, the date of purchase, and the name and address of the sales tax dealer from whom the property was purchased.

SUBMISSION PROCESS

1. Submit a signed copy of the enclosed application form with supporting documentation via certified mail or hand delivered to:

NOTE: Incomplete applications will be taken out of queue upon determination of incompleteness or no later than 30 days after receipt of application.

2. Completed applications will be processed, signed by DEP, and returned to the applicant within 60 days after receipt of completed application.
3. Once your DEP application has been approved and returned, you will have up to six (6) months to submit a form DR-26S (Application for Refund of Sales and Use Tax) to the Department of Revenue. Attach a copy of the complete (and signed) DEP application package.
4. The Department of Revenue will process the DR-26S and issue a refund within 30 days after formal approval and upon availability of funding.
